- 2. Facilitation of online conversations of small groups of no more than 15 people as well as one on one engagement directly with various stakeholders.
- 3. Capturing and Synthesizing information from multiple conversations and facilitated sessions into a single written report.
- 4. Experience in engaging stakeholders in support of broader government relations and advocacy strategies.
- 5. Experience working in nonprofit, private and public sectors.
